### Background

There was discussion regarding confidential information appearing in some of the reports recommended for presentation to the board. The Brown Act allows for closed sessions for district hospitals and municipal hospitals, for medical audits or quality assurance committee reports or related deliberations (Government Code 54954.5(h)); however, clarification as to what confidential data must be included in the reports is needed to determine proper protocol.
